- ATV's on County Roads
 - The CC&R's indicate that the HOA's owners may not operate recreational vehicle on county roads. (Article 5, Section 17). The 2nd Amendment made changes to this language.
 - Comment that the CC&R's do not have the authority to control on county roads.
 - \circ This will not change the current guidelines on access to the common areas.
- Trail System
 - This item has been discussed many times over the past several years.
 - High Desert Landscape was contacted for a bid, they are very expensive and very busy.
 - Board waiting on additional proposals.
