Distribution of Assets upon Dissolution

Upon dissolution of the corporation, the Board shall provide for the distribution of all assets and liabilities of the corporation in the following manner:

- 1. All liabilities and obligations of the corporation shall be paid and discharged, or adequate provisions shall be made therefor.
- 2. Assets held by the corporation on condition requiring return, transfer, or conveyance,

which condition occurs by reason of the dissolution, shall be returned, transferred, or conveyed in accordance with such requirement.

3. Assets received and held by the corporation, subject to limitations permitting their use

only for charitable, religious, eleemosynary, benevolent, educational, or similar purposes, but not held upon a condition requiring return, transfer, or conveyance by reason of the dissolution shall be transferred or conveyed to one or more domestic or foreign corporations, societies, or organizations engaged in activities similar to those of this corporation, in accordance with a plan of distribution adopted pursuant to the Colorado Revised Nonprofit Corporation Act which is not inconsistent with these Articles of Incorporation.

4. Assets received and held by the corporation not subject to liabilities, conditions or use

limitations, as specified in paragraphs 1, 2 and 3 above, shall be distributed to the Owners of Lots in equal shares.

5. Any remaining assets may be distributed to such persons, societies, organizations,

governmental entities, political subdivisions, or domestic or foreign corporations, whether for profit or nonprofit, as may be specified in a plan of distribution adopted pursuant to the Colorado Revised Nonprofit Corporation Act and which is not inconsistent with these Articles of Incorporation.
