- The Strive house was talked about and what is going on with it and if it is occupied or not.
- Processing violations will not produce instant satisfaction a violation letter has
 to be mailed and steps have to taken and laws followed on the processing of
 violations and weed control.
- There needs to be a range of dates for the start up of irrigation to get running and find out if there are breaks in the lines. The system is 15-20 years old. Ditch is very dirty when initially started. HOA like to let ditch flush before startup.
- Pumpkin Ridge re-zoning from R4 single family to R5 will cause more congestion and traffic on Unaweep and 29 Road. Not beneficial for the surrounding 300 homes.

Presentation / Review of the 2020, 2021, and 2022 Financials:

- Tree Remediation is the biggest issue on the budget.
- 2022 the dues increased to \$300
- 3 major concerns for HOA
 - Fencing will be a discussed more in the future

> Trees - along Unaweep - wrong type - diseased - 7 trees will be removed this year. Alpine Trees is helping the board with this issue
