Unfinished Business:

- Pumpkin Ridge Discussion
  - Recap of actions taken last year to stop rezoning of undeveloped parcels of land.
  - City council rejected the petition.
  - The project has not moved forward at this time, nor have any notifications been received to suggest development progress.
  - Comment made that weeds in those undeveloped areas are overgrown and becoming a problem.
  - The Association is unsure who is now responsible for the maintenance of that land.

- Comments made that financials and current budget look good.
- HPM was commended on collections efforts made this past year.
- Proposed 2023 Budget was approved. M/S/C 0 opposed.

Open Forum:

- Recap of the fencing issue last year on Unawee Avenue
  - Resolved between the Association and insurance
  - Comment made that per Colorado law; fences built along two properties are the shared responsibility of the property Owners.
  - The original vinyl panels are not available anymore. Color match as close as possible.

- As long as the replacement panel color and material is congruent to the neighborhood (white /tan and vinyl) then it should not violate ACC guidelines.
  - Question regarding shells in irrigation water, any way to prevent?
- Ash Trees
  - Comment made from the Board that this is an on-going project.
  - The Association received recommendation to wait at least 18 months before replacing trees.
  - New trees will not be Ash, instead, approved, insect/disease resistant native to the area.
  - Comment made from Owner that there is a city program that they took advantage of last year that dealt with the treatment of Ash Trees.
  - Information can be found on the City of Grand Junction website.
- ACC Requests
  - Homeowners were directed to fill out an ACC request form before starting any landscaping work this summer. This form can be found on HPM webpage.
  - Comment made that a form is not necessary if windows are being replaced with like materials.
  - Comment made that windows may be covered under a lifetime warranty through 84 Lumber.

- Jim McKenzie and Bob Larimer resigned from the Board.
- Duane Erkman self-nominated to serve as an irrigation consultant for the Board only.
- Motion to accept Audrey Bailey, Tom McKenzie, Chris McGillivray, Shannon Lowery, and to serve as the current slate of Directors. M/S/C 0 opposed.
